PERMIT APPLICATIONS FOR DIFFERENT CATEGORIES OF FILMING:

Please, contact us 30 days in advance to evaluate your project's needs, some historical places are subject to special authorization no matter what size the crew is

1. Filming with a small crew

(from one to ten workers with shoulder supported camera or camera tripod, no obstruction to vehicle traffic)

This category includes the following:

Students' workshops

Television reports using shoulder supported camera or tripod;

Photographic sessions for architectural purposes (surveys, research, study) with or without tripod (on location);

Photographic sessions, with or without tripod (on location)

The following requests are not included in the small crew category (and are therefore part of category filming with large crew):

- Filming, no matter the equipment, on public or private location, be it indoor or outdoor, for which special access permits are required.
- Filming, no matter the equipment, which might interfere with normal vehicular or pedestrian traffic; Filming which would cause disturbance of the peace (i.e. loud music);
- Filming entailing actors dressed like firemen, policemen or other institutional police force representatives and/or using vehicles belonging to any of the above mentioned; Filming which entails violation to the traffic regulation (car chase, U-turns, high speed etc.); Filming relying on special effects (snow, rain, fire, smoke, Filming);
- Filming requiring access to restricted parking and traffic control; total or partial closure of public street; vehicle clearance.

In the case that one of above-stated circumstances is present, the Filming can be **interrupted**

immediately by the Municipal Police.

2. Filming with a large crew

(ten or more people, with heavy equipment such as: dolly, mobile camera, generators, fixed lights, etc.), interfering in any way with the normal vehicular and pedestrian traffic (see all previous instances).

Each project falling into this category will require special permits and prior evaluation

IN ORDER TO ASSESS THE KIND OF PERMIT NEEDED, THE PRODUCTION COMPANY (OR HIS REPRESENTATIVE ON LOCATION) MUST FILL IN AND RETURN THIS APPLICATION TO THE FILM COMMISSION'S OFFICES.
